# Det motsatte av å lytte til innbyggere



til lang tids ompllassering i norske miljø i Sør-Norge. Ofte hjemme hos norske familier. Selv om disse var vennligsinnde medførte det likevel sterk kulturpåvirkning. Og brenningen medførte at hele den materielle delen av kulturen forsvant.

Alt dette førte til at det etter krigen var svært få som definerte seg som samiske. Resultatet fra folketellingene i 1930 og 1950 taler sitt tydelige språk. I mange distrikter i Nord-Troms og Finnmark var de som definerte seg som samisktalende sunket med over 90% fra 1930 til 1950. I noen kommuner med flere hundre samer i 1930, var det ikke en eneste som registrerte seg som samisk i 1950.


Den samlede virkning av dette er ofte grunnen til at enkelte samer også i dag er blant de som er skeptiske til krav om samiske rettigheter. En så langvarig undertrykking som den samiske kulturen har vært utsatt for, kan ikke repareres på et par tiår. For å gjenreise sjøsamisk kultur trengs det langvarig arbeid. Heldigvis har den samiske oppvåkningen siden 1970-tallet medført at stadig flere anser seg som samiske, også i kystområdene. Men en gjenreising av den sjøsamiske kulturen kan ikke baseres på personlige holdninger alene.

Dersom du samarbeider med oss, kan du...

I den sosialdarwinistiske perioden ble samer og samisk kultur ansett som primitiv. Dette ble understøttet av at den samiske befolkningen hadde sakket akterut økonomisk. En kunne derfor se et tydelig økonomisk skille mellom samer og nordmenn når det gjaldt boligstandard og materielle forhold. Forskjellsbehandling og den åpenbare rasismen medførte at det å være av samisk slekt ble noe mange skammet seg over og forsøkte å skjule.

Evakueringen og brenningen av Finnmark og Nord-Troms under krigen ble også et voldsomt slag mot sjøsamisk kultur. Evakueringen førte








The risk of corruption is associated with several key processes in the municipalities that in various ways affect the role of elected officials, leaders, and employees.



- When there is close contact between elected officials and certain special interests.
- When politicians in the municipality are invited on trips or gatherings



## Exercise of Authority

### Red flags:

- When case workers can make significant decisions on their own without consulting colleagues or their immediate supervisor.
- When the content of contacts and meetings between stakeholders and the municipality is not documented and filed.
- When employees with decision-making authority have contact with stakeholders who are dependent on the individual's decisions or recommendations, without involving others.



### Red flags:

- When a manager or employee knows or is friends with the service user or their relatives.
- When you, as an employee, receive offers of benefits from a service user or their relatives.
- When the service is provided directly between the service user and an employee, without the involvement of a colleague.



## Community Development

### Red flags:

- When a business leader or owner offers the municipality generous gifts or contributions to social or cultural initiatives.
- When private parties are allowed to use facilities or buildings that are funded by the municipality.
- When the municipality is to invite resource persons to participate in development workshops and partnerships.
- When private individuals approach the municipality requesting collaboration and assistance to secure business operations and jobs in the municipality.
- When loans and grants from the municipal business fund are to be distributed.

## Youth house


- It's not mandated by law, so some municipalities may not have such offerings. Libraries fulfill some of the same functions.
- Youth centers are powerful creative arenas that generate a lot of activity. The target group is usually between 13 and 19 years old. All usage is free, including practice rooms for music, dance, film, gaming, cafe, etc.

## Composition of the Councils

The council consists of 4 politically elected members with deputies, as well as 5 user representatives from pensioner associations or other organizations or associations that are actively involved with the elderly. The majority of the council members should be retirees.

The council members are elected for 4 years, and the election takes place for each electoral period.







Idea meeting about the future of Oslo. We invited to an online meeting using Facebook's live video feature. An SMS was sent out in advance to all citizens over 16 years of age with a link to the draft plan. The draft municipal plan was downloaded 13,000 times, and the website was viewed by 140,000 citizens. The Facebook meeting lasted two hours, and the online idea meeting resulted in 250 inputs and new ideas.


Oslo municipality
