Erasmus+ budget 2021 - 2027

- ✓ The programme's budget is **€26.2 billion**, compared with **€14.7** billion for 2014-2020.
- ✓ With this increased budget, Erasmus+ will be more inclusive, more digital, and more green.

What are the Partnerships for Cooperation?

✓ Partnerships for cooperation supported under Erasmus+ allow organisations and institutions to increase the quality and relevance of their activities in the fields of education and training

Participating organisations can:

- Gain **experience** in international cooperation
- Develop and strengthen capacities
- Exchange good practices with partners in other countries and create transnational networks
- Produce joint results with a European dimension, an innovative character and of high quality

OBJECTIVES

Small-scale Partnerships aim to:

- Attract and widen access for newcomers
- Support the **inclusion** of target groups with fewer opportunities
- Promote active European citizenship and bring the European dimension to the local level

- Addressing common needs and priorities
- Enabling transformation and change (at individual, organisational level)

Activities relevant for the project

- ✓ **Project management** (planning, finances, coordination and communication between partners, monitoring and supervision, etc.)
- ✓ Learning, teaching and training activities
- √ Capacity building
- ✓ Meetings and events
- ✓ Project **results** (publications, e-learning tools, curriculum/course development, case studies, development of standards and profiles, etc.)
- ✓ Activities aimed at sharing project's results

Eligibility Criteria for Small scale partnerships (1)

Who can apply?

✓ Any type of organisation (public or private) active in any field of education, training and youth established in an EU Member State or third country associated to the Programme* can be the applicant. One organisation applies on behalf of whole partnership.

Number and profile of participating organizations

✓ Minimum <u>2 organisations</u> from 2 different EU Member States and third countries associated to the Programme.

Venue of the activities

✓ All the activities must take place in the countries of the organisations participating in the project

* North Macedonia, Serbia, Iceland, Liechtenstein, Norway, Turkey

Eligibility Criteria for Small scale partnerships (2)

Project duration

✓ Between 6 and 24 months

Funding rules

✓ The proposed funding model consists of a lump sum (a single fixed amount covering all costs of eligible activities linked to the implementation of the project): 30 000 EUR and 60 000 EUR.

Where to apply?

✓ To the National Agency of the country in which the applicant organisation is established.

When to apply?

✓ Applicants have to submit their grant application by 4 October 12:00:00 (midday Brussels time) for projects starting between 1 January and 31 August of the following year rasmus+

Eligibility Criteria for Cooperation partnerships (1)

Who can apply?

- ✓ Any type of organisation (public or private) active in any field of education, training and youth established in EU Member States and third countries associated to the Programme*.
 One organisation applies on behalf of whole partnership.
- ✓ Cooperation Partnerships may also involve other partners from the public or private sector that contribute to the implementation of specific project tasks/activities or support the promotion and sustainability of the project as <u>Associated partners</u>.

Number and profile of participating organizations

✓ Minimum <u>3 organizations</u> from 3 different EU Member States, third countries associated to the Programme. Organisations from <u>third countries not associated to the Programme can be involved as partners</u> (not as applicants), if their participation brings an essential added value to the project, e.g. involving partners from Ukraine.

* North Macedonia, Serbia, Iceland, Liechtenstein, Norway, Turkey

Eligibility Criteria for Cooperation partnerships (2)

Venue of the activities

✓ All the activities of a Cooperation Partnership must take place in the countries of the organisations participating in the project, either as full partners or as associated partners.

Project duration

✓ Between 12 and 36 months

Funding rules

✓ The proposed funding model consists of a lump sum (a single fixed amount covering all costs of eligible activities linked to the implementation of the project): 120 000 EUR,
250 000 EUR and 400 000 EUR.

Eligibility Criteria for Cooperation partnerships (3)

Where to apply?

✓ To the National Agency of the country in which the applicant organisation is established.

When to apply?

✓ Deadlines for Call 2024 have not been announced (please see Erasmus+ programme guide 2024 to be published in Autumn, 2023).



Supporting persons affected by the war in Ukraine

✓ Erasmus+ upcoming application rounds - encouraging future projects to focus on aspects related to the Ukraine war and its effects




Project applicants are suggested to include activities linked to the **integration of Ukrainian refugees** and the promotion of European common values.

These topics are well embedded into the exisiting narrative of the Programme, with inclusion and diversity, and participation and civic engagement being key transveral priorities of the Erasmus+ Programme.
