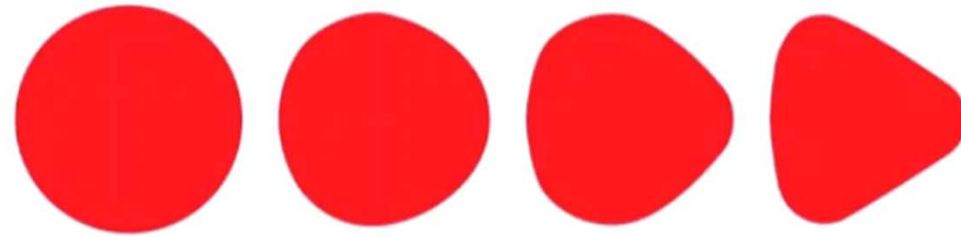

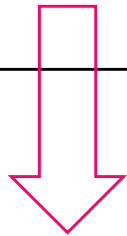

## Context: why we decided to involve libraries?

- Globally, 320,000 public libraries and more than a million of parliamentary, national, university, scientific and research, school and special libraries to ensure that information and knowledge are available to citizens in the digital age.
- In Spain, there are 24,442 libraries, which receive 197.07 million face-to-face visits and 191.90 million virtual visits. In total, there are 22.26 million people users, to this we must add the number of students from non-university educational centres, which means that more than 50% of the population make use of this service.
- In Mallorca, there are 72 public libraries with 109 trained workers and 127,994 users.
- Spanish Law 10/2007 on reading, books and libraries, it states that the library's mission is to facilitate equal opportunity access for all citizens to documents published or disseminated in any medium. It also underlines as a fundamental value "equality for all users to access library materials, facilities and services, without discrimination based on origin, ethnicity, religion, ideology, gender or sexual orientation, age, disability, economic resources. or any other personal or social circumstance."

**Goal 9c.** Significantly increase access to technology of information and communications technology and provide universal and affordable Internet access in less developed countries by 2020

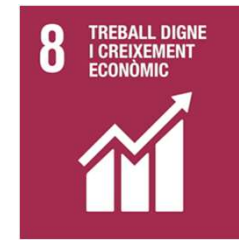

## PUBLIC LIBRARIES IN ROMANIA FACILITATE ACCESS TO AGRICULTURAL SUBSIDIES



The purpose of this collaboration is multiple:

- Help farmers fill in the financing applications easier. They usually have to travel to the nearest local APIA offices. This process could last several days (between 2 days and a week, according to the farmers), and required them to pay for the transportation.
- Provide the local public administration with the opportunity to help the farmers. Most mayors and local councils are interested in the farmers obtaining the subsidies earlier and on time. The existence of computers connected to the Internet in public libraries makes this process much simpler.
- Help the library be more useful to the community. Public libraries are brought up-to-date at a very alert pace, provide new services, computer and Internet access.



## Challenges ...

- Generate an alliance between actors, add different actors, alliance networks. Real, physical network.
- Recognition of the 2030 Agenda by all actors
- More coordination at different levels.
- Influence governments and make them aware of the importance of education for sustainable development and include it in their local policies
